2. **Associate Member:** An association, company or any other legal entity shall be eligible to become an Associate Member of the Association, if it supports the functioning, promotion, research, development and evolution of the Space Domain Activities.
3. **Start-up Member:** An association, company or any other legal entity shall be eligible to become an Start-up Member of the Association if it is a start-up in the Space Domain Industry\*\* and supports the functioning, promotion, research, development and evolution of the Space Domain Activities.
